And what the matter was placed before the WRC in its 293rd meeting held on June 12-14, 2018, and the Committee decided as follows:-

"... The Management in its Executive Committee meeting held on 15.05.2017 passed a resolution to reduce 01 mil of the B.Ed. course.

Hence, reduction of one unit is permitted."

Now, therefore, the intake of the institution is here by reduce from 2 units (100 students) to 1 units (50 students) to conduct of B.Ed. course.
