WHEREAS, WRC, NCTE had granted recognition/permission, Late shri Govindrao Wanjari College of Education, C/o Amar Sewa Mandals Kamla Nehru Mahavidyalaya, Sakardara Chowk, Nagpur-440009, Maharashtra vide order WRC/2-32/123241/76/2005/63/2 dated 09.08.2005 to start the B.Ed. course and revised order no. WRC/APW01782/123241/2015/136852 dt. 25.05.2015 with annual intake of 100 students

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 12.01.2015. The institution submitted affidavit vide letter dated 13.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 23.05.2015.

The institution vide its letter dated 19.05.2018 & 09.06.2018 has requested this office to reduce the intake of 2 units (100 students) to 1 unit (50 students).

And whereas, the matter was placed before the WRC in its 293rd meeting held on June 12-14, 2018, and the Committee decided as follows:-

"... The Management in its Executive Committee meeting held on 15.05.2017 passed a resolution to reduce 01 unit of the B.Ed. course.

Hence, reduction of one unit is permitted."

Now, therefore, the intake of the institution is here by reduce from 2 units (100 students) to 1 unit (50 students) to conduct of B.Ed. course.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
