AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution or 25.05.2015.

The insplantion vide its letter dated 19.05.2018 & 09.06.2018 has requested this office to reduce the intake of 2 units (100 students) to i anh (50 students).

And whomas the matter was placed before the WRC in its 293rd meeting held on June 12-14, 2018, and the Committee decided as follows:

"... The Management in its Executive Committee meeting held on 15.05.2017 passed a resolution to reduce 0) unit of the B.Ed. course.

Hence, reduction of one unit is permitted."

Now, therefore, the intake of the institution is here by reduce from 2 units (100 students) to 1 units (50 students) to conduct of B.Ed. course.
