Hostel Accommodation, Hostel Fee Concession, and Institutional Fee Waiver Policy for Students

Introduction:

At Late Shri Govindrao Wanjari College of Education, Nagpur, we aim to provide a conducive and supportive environment for our students' academic pursuits. This policy document outlines the guidelines and criteria for hostel accommodation, hostel fee concession, and institutional fee waiver to assist eligible students who may require financial assistance.

Hostel Accommodation:

a. Availability: Hostel accommodation is available to students pursuing full-time academic programs at Late Shri Govindrao Wanjari College of Education, subject to the availability of rooms. Hostel facility is located just in 3kms radius of college campus.

b. Eligibility: Priority for hostel accommodation will be given to students from outside the local area and international students. However, students residing locally may also apply for hostel accommodation, subject to availability.

c. Application Procedure: Students interested in availing hostel accommodation must submit a formal application to the hostel administration within the specified deadline.

d. Allotment Process: The allotment of hostel rooms will be done based on the availability of rooms, priority criteria, and any special needs or circumstances of the applicants.

e. Hostel Rules and Regulations: Students availing hostel accommodation must adhere to the rules and regulations set forth by the hostel administration to ensure a safe and harmonious living environment.

Hostel Fee Concession:

a. Eligibility: Students facing financial constraints and in need of financial support to pay for hostel accommodation may apply for a hostel fee concession. Students from SC/ST/OBC category can submit the proof of reservation to avail the benefits. Students from EWS category will be given priority.

b. Application Procedure: Eligible students must submit a formal application for a hostel fee concession along with supporting documents, such as income certificates, to the college's financial aid office.

c. Evaluation: The applications for hostel fee concession will be evaluated by the college's financial aid committee based on the financial need and availability of funds.

d. Confidentiality: All information provided by students during the application process will be treated with the utmost confidentiality.

Institutional Fee Waiver:

a. Eligibility: Students facing exceptional financial hardships may apply for an institutional fee waiver for tuition and other institutional fees. Merit based scholarship is also available to students performing 90% or more aggregate in previous academic qualification.

b. Application Procedure: Eligible students must submit a formal application for an institutional fee waiver along with supporting documents, such as income certificates and relevant financial statements, to the college's financial aid office.

c. Evaluation: The applications for an institutional fee waiver will be evaluated by the college's financial aid committee based on the severity of financial need and the availability of funds.

d. Partial Waiver: The college may consider partial fee waivers, depending on the circumstances of the applicants and the availability of funds.

e. Confidentiality: All information provided by students during the application process will be treated with the utmost confidentiality.

Note: The availability of hostel fee concessions and institutional fee waivers is subject to the college's financial resources and policies. The decision of the college's financial aid committee regarding fee concessions and waivers will be final and binding.

By offering hostel accommodation and financial support through fee concessions and waivers, Late Shri Govindrao Wanjari College of Education aims to ensure that no deserving student is denied access to quality education due to financial constraints.

This policy document is effective from 03/07/2017.

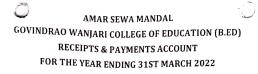
